1. Scope of work:

- i) Duly signed & stamped scan of document in which Name of the Firm, Address with contact number, FAX, E-mail of the Firm and Firm's Bank Account Details with Bank Name & Address and IFSC / RTGS codes mentioned.
- ii) Scan copy of registration certificate of local agency which must be registered in Class- IV contractor eligible for supply of Electrical work with State Government in Patna region must be uploaded.
- iii) Scan of PAN card (in name of Proprietor in case of Proprietorship Firm) & GST certificate.
- iv) Scan of Affidavit as per Annexure-I.
- v) Scan of the receipt of deposit through NEFT / RTGS for Cost of Document.
- vi) Scan of the receipt of deposit through NEFT / RTGS for EMD.
- vii) The bidder must have successfully completed at least one single work order for the supply of electrical materials of value not less than Rs.5,00,000/- (Rupees Five Lakhs only) during the last three financial years (2022-23 to 2024-25) in any Government Department or reputed University.
- viii) Scan copy of Income Tax Return of last three financial years i.e., 2022-23, 2023-24 and 2024-25.
- ix) The financial bid of only those bidders shall be opened who will qualify in evaluation of Technical Bid.

3. Terms and Conditions: -

- i) Tender shall not be acceptable through post, courier or any offline mode. Interested bidders are advised to submit the bid only through our e-Tendering portal.
- ii) Scanned documents as mentioned in Eligibility criteria is mandatory. Bidder should upload all the scan of genuine documents otherwise their technical bid shall be declared non-responsive.
- iii) Original document of Affidavit as per Annexure-I should be submitted by bidder during opening of Bid.
- iv) Bidder or their authorized representative should remain present during the Pre-Bid meeting and at the time of opening of Bid. No complaint shall be entertained on this count, if the tenderers are not present on these date and time.
