11. AWARD OF CONTRACT AND COMMENCEMENT OF OPERATIONS

The CNLU, PATNA will award the Contract to the successful Bidder whose has quoted the total lowest annual premium, provided further that the Bidder has been determined to be qualified to satisfactorily perform the Contract. A letter of award will be issued to the successful bidder who should commence the service from 1st April, 2026.

12. TERM / PERIOD OF CONTRACT/POLICY

The contract is for a period of one year. The policy will remain in force for the entire policy period. The Insurance Company/Bidder will not cancel the policy mid-way till its expiry.

13. GENERAL TERMS & CONDITIONS

- a. The annual premium quoted should be inclusive of all applicable taxes and duties for all the items. Only GST would be payable extra, and the GST should be mentioned in the column provided in the financial bid document. Other taxes/ cess, if any, would have to be included in the premium. It is also clarified that any change in the GST (increase/decrease) would be dealt with at actual.
- b. Any claim for increase in premium rates during the policy period on account of any reason whatsoever will not be entertained.
- c. Confidentiality: The Insurance Company shall maintain strict confidentiality of all the tender information and data coming in the possession of the Insurance Company as a result of awarding the contract. Also, any oral, written or other information disclosed for evaluation or for any other purposes shall be considered as confidential information passed on to the Insurance Company. Any violation of the same will be liable for action under the law which shall entitle CNLU, PATNA to claim damages apart from taking action under the appropriate Law.
- d. Usage of data/tender/information: The agency shall ensure that the tender, data, information etc is not used or permitted to be used in any manner (directly or indirectly) incompatible or inconsistent with that authorized by CNLU, PATNA. The confidential information should be safeguarded, and the Insurance Company shall take all necessary actions to protect CNLU, PATNA and its employees' interest against misuse, loss, destruction, alterations or deletions thereof. Any violation of the same will be liable for action under the law which shall entitle CNLU, PATNA, to claim damages from the Insurance Company apart from taking action under the appropriate Law. This is an irrevocable condition, and it will continue to be in force even after the agreement between the Insurance Company and CNLU, Patna., ceases.
- e. Breach of terms and conditions: In the event of any breach or threatened breach of any clause by the Insurance Company and / or individual assigned by the Insurance Company for the Performance of the services, the Insurance Company shall be liable to pay damages as may be quantified by CNLU, PATNA. Apart from the above, CNLU, Patna., shall have the right to proceed against the Insurance Company and / or its assigned person/s under appropriate law.

- f. Time is the essence of contract: For Processing of claims the Insurance Company shall carry out and provide the services/ settle the claims, within reasonable time.
 - g. Conditional Tenders are liable to be rejected. CNLU, PATNA reserves the right to either accept or reject any of the quotations or conditions in the quotations submitted by the bidders without assigning any reasons thereof.
 - h. The successful Bidder after placement of order is required to enter into an MOU/agreement with CNLU, PATNA. The Terms and Conditions of the Tender also form part of the MOU/agreement.
 - i. In case of any dispute, efforts will be made to mutually settle the dispute. In this regard, the decision of the Hon'ble Vice Chancellor, CNLU, Patna is final. CNLU, PATNA has absolute right to accept or reject any bid or offer at any stage.
 - j. If a bidder has been given order and later on it is found that its services are not satisfactory, then CNLU, PATNA has absolute right to cancel / terminate the order and in such case, the bidder has to refund back all the premium paid. Decision of CNLU, PATNA in this regard will be final and binding.
 - k. **Jurisdiction:** All matters pertaining to this shall be subject to the jurisdiction of the courts in Patna High Court only.
 - l. CNLU, PATNA reserves the right to cancel the Tender wholly or partially without assigning any reason whatsoever.
 - m. The successful bidder will be awarded all the insurances on a whole bouquet basis.
 - n. CNLU, PATNA shall not be bound to accept the lowest bid and reserves the right to reject any or all the bids without assigning any reason.
- i. CNLU, Patna may at its discretion extend/ change the schedule of any activity and intimate the prospective bidders by notifications through eproc2 portal.
 - ii. CNLU, Patna reserves the rights to accept or reject any bids or accept all bids either in part or in full or to split the order, or to annul the bidding process without assigning any reasons thereof.
