
NOTICE

As directed by the Hon'ble Vice-Chancellor, it is hereby notified that students presently having 50% attendance are permitted to appear in the ongoing Mid-Semester Examination, February, 2026 subject to submission of a written declaration/undertaking.

The concerned students shall submit an undertaking stating that they shall maintain a minimum of 67% attendance by the end of the semester, in accordance with the University Attendance Rules. This permission is purely conditional and shall not be treated as a precedent for future semesters.

It is further clarified that if any such student fails to maintain the prescribed minimum attendance of 67% by the time of the End-Term Examination, 2026 no relaxation or condonation shall be granted, and the student shall not be permitted to appear in the End-Term Examination, 2026. This relaxation shall also not be applicable to those papers which have already been conducted prior to the issuance of this notice.
