## NOTICE

As per para 8 (v) of the DPIIT Office Memorandum dated 5<sup>th</sup> May, 2025, the DPIIT-IPR Chair at Chanakya National Law University, invites application from the eligible students, **currently studying IPR in their courses**, in LL.B.(3yrs/5 yrs) and LL.M.(1yr), for **scholarships for Rs.50,000/- (Rupees Fifty thousand only)**, to **two selected students** (one from LL.B. and one from LL.M.) for their excellent performance in the subject of Intellectual Property Law as well as overall performances in the previous semesters, and additional interest and contribution in the field of IPR.

### **Eligibility for scholarship under this provision:**

- The student scoring highest score in IPR compulsory paper in Undergraduate course (LL.B.)
- The student scoring highest score in IPR stream in postgraduate course (LL.M.)

### **Other conditions for scholarship under this provision:**

- The students must present at least one original article on IPR related topics during their academic year.
- Such student considered eligible by the university must actively participate in IPR Chair activities in the University.
- The University may also ask the eligible students to submit one final report in regard to works undertaken in the field of IPR.
- The scholarship would, however, be subjected to securing a minimum of sixty percent marks at undergraduate level.
- The scheme is applicable to such students who have taken admission in regular, full-time LL.B., LL.M. and Ph.D. course.
- Distance mode of education will not be considered under the scheme.
- Any student who discontinues studies without prior approval of the University will have to refund the whole amount and the concerned institution will be responsible for this.
- The University may terminate the scholarship of any student in case of:
  - Misconduct of the awardee, if any, reported in the University/institution.
  - Candidates being found ineligible at a later date shall face the penal action and will also be liable to refund the entire scholarship amount paid.
  - Unsatisfactory progress report (i.e. if the candidate scores less than 60% marks)

The eligible applicant may send their application with CV and supporting documents by email: [iprchair@cnlu.ac.in](mailto:iprchair@cnlu.ac.in), by 20<sup>th</sup> March 2026.
