1. Scope of work:

This document outlines the specifications and conditions for the Supply, Installation, Testing and Commissioning of 2x10 10 KVA on-line UPS and Electrical work. Bidders are required to submit proposals based on the details provided as per the work description mentioned in Annexure-II.

2. Eligibility Criteria: Bidder fulfilling all criteria mentioned below and who submit scanned copies of all documents shall only be eligible: -

- i) Scan of the self-declared document (Name of the Quotationer, Address with contact number, FAX, E-mail of the Firm and Firm's Bank Account Details with Bank Name & Address and IFSC / RTGS codes).
- ii) Scan of document of Registration Certificate of Company / Proprietorship Firm / Partnership Firm.
- iii) Scan of PAN card (in name of Proprietor in case of Proprietorship Firm & in name) & GST certificate.
- iv) Scan copy of ITR, Audited profit and loss statements and balance sheet for the last three financial years i.e., 2022-23, 2023-24, 2024-25.
- v) Scan of EMD & Cost of Document.
- vi) Scan of Affidavit as per Annexure-I.
- vii) Scan of valid Character certificate of bidder issued from the office of the Superintendent of Police.
- viii) Scan of Affidavit as per Annexure-I on Rs. One Hundred Non-Judicial Stamp Paper
- ix) Scan of original document of at least one work order / agreements for Supply, Installation & Commissioning of UPS and Electrical related work or similar nature of work in reputed Institutes of Higher Learning / Indian Universities / Central or State Government Organizations / Professional bodies / PSUs etc. during the last three financial years.
- x) Scan of Brochure with detailed specifications of quoted make & model 10 KVA on-line UPS.
- xi) Scan of Manufacturer- ISO 9001, CE certified, BIS Approved copy.
- xii) Scan of UPS should be ROHS compliance.
- xiii) Scan of document in proof of OEM's Service Center in Patna.
- xiv) Scan of tender specific duly signed / digitally signed Authorization & Compliance from OEM of UPS
- xv) The financial bid of only those bidders shall be opened who will qualify in evaluation of Technical Bid.

3. Terms and Conditions: -

- i) Tender shall not be acceptable through post, courier or any offline mode. Interested bidders are advised to submit the bid only through our e-Tendering portal.
- ii) Scanned documents as mentioned in Eligibility criteria is mandatory. Bidder should upload all the scan of genuine documents otherwise their technical bid shall be declared non-responsive.
- iii) The bidder shall quote rates separately for Part-A: Electrical Items (Schedule Items) and Part-B: Electrical Items (Non-Schedule Items).
- iv) Original document of Affidavit as per Annexure-I should be submitted by bidder during opening of Bid.
- v) The quantity of items mentioned in Annexure-II is subject to variation based on actual requirements. Accordingly, payment will be made as per the actual quantity and measurements recorded.
- vi) Bidder or their authorized representative should remain present during the Pre-Bid meeting and at the time of opening of Bid. No complaint shall be entertained on this count, if the tenderers are not present on these date and times.
- vii) The price will be remain firm and fixed during the pendency of contract. It will not vary on any account including revision of taxes, imposition of new tax or any contingency whatsoever.
- viii) **Cost of tender fee: Rs. 1250/- (Rs. One Thousand Two Hundred Fifty) only** and should be submitted through e-payment mode. Scan of the receipt of depository should be uploaded on our e-tendering portal while submitting the bid.
- ix) **Cost of EMD: Rs. 15,000/- (Rs. Fifteen Thousand) only** and should be submitted through e-payment mode. Scan of the receipt of depository should be uploaded on our e-tendering portal while submitting the bid.

- xi) Incomplete bid and bid without genuine documents are liable for rejection. No responsibility will be taken for any type of technical glitch while online submission of bid.

cancel the bidding process at any time prior to the award of contract, without assigning any reason whatsoever.

- xiii) The work is required to be completed within the period mentioned against the works i.e., within **30 days**. It will be reckoned from the date of the issue of work order after agreement. If the work is not completed within the stipulated completion period liquidated damages @ 0.5% of agreement value per day of delay will be levied (subject to maximum of 10%). If the liquidated damages reach the level of 10% of the agreement value the contract is liable to be rescinded.
- xiv) Work shall be done strictly as per specification and direction of competent authority of CNLU, Patna.
- xv) Any Suggestions/Clarifications may be put forth in the pre bid meeting or through written letter / e- mail to enquiry@cnlu.ac.in up to 23.03.2026 till 12:00 pm.
- xvi) Dispute, if any, will subject to Patna Jurisdiction only. The decision of Vice-Chancellor, CNLU will be final and binding with both the parties viz: bidder and the University.
- xvii) Price should be quoted in Indian Rupees only. The price will remain firm and fixed during the pendency of Contract and will not be changed for any reason (including revision of taxes & levies whatsoever).
- xviii) All labour laws & regulations are to be followed by the bidder.
- xix) The bidder shall be bound to follow the restriction on the movement of labour, materials imposed by any other authority connected with the site due to security or any other reasons connected with the event. No claim shall be entertained on this account.
- xx) The bidder shall take all precautions to avoid accidents by exhibiting necessary cautions boards, lights, flags etc. and ensure that no hindrance is caused to the traffic. Bidder shall be responsible for all damages, accidents, caused due to negligence.
- xxi) The contractor shall arrange all tools and plants necessary for the execution of the work at his own cost. Any loss or damage in this case will be to his account.
- xxii) Lowest responsive bidder will be considered on the total amount of bids of the respective work.
