ADMISSION NOTICE AGAINST THE VACANT SEATS / AGAINST THE SUBSEQUENT VACANCY AT CNLU, PATNA

FOR

B.B.A., LL.B. (Hons.) COURSE, ACADEMIC YEAR- 2026-27

Candidates who appeared in the CLAT-2026 Examination and who are *willing* to take admission to B.B.A., LL.B. (Hons.) Course in our University **against few vacant seats/ against the subsequent vacancy, if any**, can apply under the following categories :

- (i) **General Category** (only those candidates should apply under General Category whose All India Rank (AIR) in CLAT-2026 Examination is **below 3,000 (Three Thousand only)**);
- (ii) **Backward Classes (BC-II)** for Bihar Domicile only. (only those candidates should apply under Backward Classes (BC-II) whose All India Rank (AIR) in CLAT-2026 Examination is **below 8,000 (Eight Thousand only)** (Right now there is no vacant seats in BC-II Category but in future should any subsequent vacancy arises, admission would be offered to those who apply in response to this notification);
- (iii) **Extremely Backward Classes (EBC)** for Bihar Domicile only. (only those candidates should apply under Extremely Backward Classes (EBC) whose All India Rank (AIR) in CLAT-2026 Examination is **below 12,000 (Twelve Thousand only)** (Right now there is no vacant seats in EBC Category but in future should any subsequent vacancy arises, admission would be offered to those who apply in response to this notification);
- (iv) **Economically Weaker Sections (EWS)** for Bihar Domicile only; (only those candidates should apply under EWS Category whose All India Rank (AIR) in CLAT-2026 Examination is **below 8,000 (Eight Thousand only)** (Right now there is no vacant seats in EWS Category but in future should any subsequent vacancy arises, admission would be offered to those who apply in response to this notification);

- (v) **Scheduled Caste (SC)** for Bihar Domicile only, who have written CLAT-2026 Examination. (Right now there is no vacant seats in SC Category but in future should any subsequent vacancy arises, admission would be offered to those who apply in response to this notification);
- (vi) **Scheduled Tribe (ST)** for Bihar Domicile only, who have written CLAT-2026 Examination. (Right now there is no vacant seats in ST Category but in future should any subsequent vacancy arises, admission would be offered to those who apply in response to this notification);
- (vii) **Person with Disability (PWD)** - (Right now there is no vacant seats in PWD Category but in future should any subsequent vacancy arises, admission would be offered to those who apply in response to this notification, who have written CLAT-2026 Examination).

NOTE :

Under WBC category, women candidates of Bihar get admission on merit based on All India Rank (AIR) CLAT-2026 rank among (i) Extremely Backward Classes (EBC-BC-I), (ii) Backward Classes (BC-II), (iii) Scheduled Caste (SC) and (iv) Scheduled Tribe (ST).

IMPORTANT INSTRUCTIONS FOR SUBMISSION OF APPLICATION FORM

Interested candidates seeking admission against the Vacant Seats/ Subsequent Vacant Seats in the B.B.A., LL.B. (Hons.) Course, Academic Year 2026-27, at Chanakya National Law University (CNLU), Patna, are required to strictly follow the instructions given below:

STEP 1: PAY APPLICATION FEE (NON-REFUNDABLE):

Before filling out the Google Form, candidates must pay non-refundable application fee of Rs. 1,000/- (Rupees One Thousand Only) through the following ICICI Bank Payment Gateway only:

Candidates must save the payment receipt/transaction details for uploading in the Google Form.

STEP 2: KEEP THE REQUIRED DOCUMENTS READY

Candidates must keep ready clear and legible scanned copies of all mandatory documents mentioned in Table A. The documents must be uploaded in the prescribed (pdf) format while submitting the Google Form.

STEP 3: FILL THE GOOGLE FORM AND UPLOADING MANDATORY DOCUMENTS

After payment of the non-refundable application fee and arranging the required documents, candidates must fill out the Google Form through the following **link** only:

All furnished particulars and uploading of the mandatory documents in the Google Form must be accurate and complete. Any incorrect, false, incomplete, or misleading information may lead to rejection of candidature.

Applications without the required documents shall be treated incomplete.

STEP 4: FINAL SUBMISSION

Candidates must carefully verify all details entered in the Google Form before making final submission. No correction or modification should be made after submission.

STEP 5: DEADLINE

The completed Google Form, along with proof of payment and all mandatory documents, must be submitted on or before Monday the 08th June, 2026.

IMPORTANT

- Submission of the Google Form without payment of the prescribed application fee (non-refundable) shall result in rejection of the application.
- Submission of the Google Form without uploading the mandatory documents shall result in rejection of the application.
- Applications and payment of application fee (non-refundable) received after the prescribed deadline (i.e. 08th June, 2026) shall not be considered under any circumstances.

Candidates are advised to complete the entire application process well before the last date i.e. 08th June, 2026 to avoid any last-minute technical glitches.

Candidates will be informed about probability of their admission, subject to vacancy and admission will be done strictly in order of their All India Rank (AIR) of CLAT-2026 result, through our website from time to time. **Subsequent vacancies, if any, shall be filled in also *only* from those candidates who have applied and have made the non-refundable application fee of Rs. 1,000/- on or before 8th June, 2026.**

The provisional admission list against the vacant seats shall be published on 11th June, 2026 on the University website i.e. <https://www.cnl.u.ac.in/clat/> and the admission process of the provisionally selected candidates shall be started from 13th June, 2026 onwards through online mode.

TABLE - A

List of mandatory relevant documents (scanned copies) for uploading in the following order as per the Google Form in a single pdf format

- Admit Card of CLAT-2026 duly signed by the invigilator.
- Grade 10th statement of marks or Matriculation Certificate for verification of Date of Birth.
- Grade 12th statement of marks.
- Caste Certificate issued by the competent authority of Govt. of Bihar, *if applicable*.
- Certificate of Economically Weaker Section (EWS) issued by competent authority of Govt. of Bihar for the last Financial Year (2025-26) (*Applicable for the EWS category candidates for Bihar only*), *if applicable*.
- PWD Certificate issued by the competent authority, *if applicable*.

At the time of online provisional admission, the candidates shall be required to pay the following University fee only for the First Academic Year (2026-27) through the above-mentioned ICICI Payment Gateway Link, failing which their candidature will be forfeited for the Academic Year 2026-27.

Total annual fee	Rs. 2,72,253/- (Two Lakh Seventy Two Thousand Two Hundred Fifty-Three only)

NOTE : The accommodation will not be provided in the Dr. Rajendra Prasad Boys' Hall (Boys' Hostel) and Gargee Girls' Hall (Girls' Hostel) of the University who are from Patna. Other students may also opt to be day scholars. Room Rent, Mess Fee etc. would be refunded within one month after getting admission to the day scholar.

Mere depositing application fee of Rs. 1,000/- (One Thousand only) does not guarantee admission. In case of vacancy, provisional admission will be granted after thorough verification of the documents of the candidates. However, if any document is found to be forged/tampered/fake etc. at any point of time, the admission shall stand cancelled automatically.

NOTE:

- (i) Candidates who wish to apply and want to be considered for both the courses i.e. B.B.A., LL.B.(Hons.) and B.A., LL.B.(Hons.) course will have to fill-up separate Google Form and will have to pay separate application fee of Rs. 1,000/.
