## CLARIFICATION

This is with reference to NIQ No. 19/2026-27 dated 21.05.2026 for Providing Horticulture Services. The following queries / Observations were received during the pre-bid stage, and the clarification / replies of the management are provided below for information of all prospective bidders.

### **I. Queries raised by M/s. Georgia Services Private Limited.**

1.	<b>Highest Turnover</b>	Kindly clarify whether, for the purpose of the tie-breaker criterion based on "highest turnover," the turnover will be assessed on the basis of the average turnover of the last three financial years or on the basis of the highest turnover achieved in any single financial year during the last three years.	In case of a tie in the quoted price among bidders, the bidder with the highest turnover shall be considered on the basis of average of last three years (2022-23, 2023-24 and 2024-25) for the award of the work. Every Bidder must submit the last three years turnover certificate duly certified by Chartered Accountant, failing which their submitted bid will be rejected. In case of a tie in turnover as well, the selection of the bidder for the work shall be decided through a lottery system
2.	<b>GST and other Deductions</b>	Whether GST is to be calculated on the total bill amount including wages, EPF, ESI and Service Charges.	GST shall be charged on the total amount as per the prevailing GST rates and applicable statutory provisions.

It is mandatory that the bidder shall submit Scanned copies of the bidder's filed Income Tax Returns for the last three financial years and minimum combined turnover of the last three financial years (FY 2022-23, 2023-24 & 2024-25) of ₹ 3.00 crore duly certified by Chartered Accountant for similar nature of work. Every Bidder must submit the last three years turnover certificate duly certified by Chartered Accountant, failing which their submitted bid will be rejected.
