

(A) The IQAC members considered and recommended to the Governing Bodies of the University for their approval the revision of course structure and subjects of Management Stream for the B.B.A., LL.B. (Honours) Programme. Meeting was held on 14 May 2026 at the Vice-Chancellor's office regarding the restructuring of Management papers for the B.B.A., LL.B. course. In this meeting Prof. Pinaki Nandan Patnaik (Dean, School of Leadership, KIIT Bhubaneswar), attended as expert, all Management faculty members CNLU, and fourth-year B.B.A., LL.B. student representatives, Mr Gaurav and Mr Satyam Kumar and subsequent meetings with the Vice chancellor. It has been unanimously suggested that total Twelve Management papers will be offered instead of Eleven from the upcoming Academic Session 2026–2031, in B.B.A., LL.B. course. Legal History paper in B.B.A., LL.B. course second semester will be replaced by Corporate Communications and Negotiation Skill.

(B) The IQAC members considered and recommended to the Governing Bodies of the University for their approval for partial amendment in the Academic regulations for UG and PG. The 05 marks earlier assigned for regular attendance to be merged/ added to other components for seminar paper for B.A., LL.B. (H) & B.B.A., LL.B. (H) and LL.M., Moot court exercise and internship for B.A., LL.B. (H) & B.B.A., LL.B. (H) and 3 Year LL.B. (H). and legal research writing (compulsory paper) LL.M. Under new evaluation scheme no written examination will be conducted for Drafting, Pleading & Conveyancing (DPC) instead it will be continuous assessment in the class regularly every week throughout the semester. New scheme for research publication and Moot court memorials and etc. for B.A., LL.B. (H) & B.B.A., LL.B. (H) and 3 Year

LL.B. (H) and LL.M., publication by students will exempt them in their projects in particular semester, subject to Viva Voce.

The meeting concluded with a vote of thanks to the members by the Hon'ble Vice Chancellor.
