NOTICE FOR ADMISSION UNDER FOREIGN NATIONAL AND NON-RESIDENT INDIAN (NRI) CATEGORIES

Applications are invited from eligible candidates seeking admission to the 5-Year B.A., LL.B. (Hons.) / B.B.A., LL.B. (Hons.) programmes under the Foreign National and Non-Resident Indian (NRI) categories for the Academic Year 2026-27 at Chanakya National Law University (CNLU), Patna.

There are five (05) seats reserved under Foreign National and five (05) seats reserved under Non-Resident Indian (NRI) categories.

Eligible candidates desirous of seeking admission under these categories may apply directly to the University on or before 15th June, 2026 through the following Google Form link (sample format of the required information and documents list is enclosed):

APPLICATION FEE:

Candidates are required to pay a non-refundable Application Fee of Rs. 7,500/- (Rupees Seven Thousand Five Hundred Only) through the following ICICI Bank Payment Gateway:

Candidates must ensure that the Application Fee is paid on or before 15th June, 2026. Applications received without payment of the prescribed fee within the stipulated time shall not be considered for admission. No correspondence in this regard shall be entertained.

ADMISSION UNDER FOREIGN NATIONAL CATEGORY:

Those who wish to apply for 5-Year B.A., LL.B. (Hons.) or B.B.A., LL.B. (Hons.) against the Foreign Nationals seats need not take CLAT-2026 and may apply directly to the University through the Google Form as mentioned above. Merit for admission under the Foreign National category shall be determined on the basis of the percentage of marks obtained in the 10+2/Intermediate examination or its equivalent.

To be eligible under this category, candidate must be a Foreign National.

The candidate must have secured a minimum of 45% marks in the qualifying examination. In cases where a grading system is followed, the equivalent percentage shall be considered. The candidate must also satisfy all other eligibility criteria prescribed under CLAT-2026.

IN THE EVENT OF A TIE, MERIT SHALL BE DETERMINED IN THE FOLLOWING ORDER:

1. Higher percentage of marks in the Class X examination;
2. Higher age of the candidate;
3. Draw of lots, if the tie still persists.

ADMISSION UNDER NRI CATEGORY:

For admission under the NRI category, candidate / the candidate's parents/either of them must be a Non-Resident Indian (NRI).

Admissions under this category shall be made strictly on the basis of the All India Rank (AIR) secured by the candidate in CLAT-2026, conducted by the Consortium of National Law Universities, Bengaluru, on 07th December, 2025.

Candidates must fulfil all eligibility requirements and guidelines prescribed under CLAT-2026.

GENERAL INSTRUCTIONS

Candidates provisionally selected for admission under the Foreign National or NRI categories for the Academic Year 2026–27 shall be required to complete the admission process by complying with all rules, regulations, and requirements notified by the University within the prescribed time.

The provisional admission list will be tentatively published on our University website i.e. <https://cnlu.ac.in/clat/> and the provisionally selected candidates will be informed through website/email.

NOTE :

- (i) Unfilled seats of the Foreign Nationals / NRIs shall not be filled in by any other categories and they shall remain vacant.
- (ii) University fee of Rs. 4,75,994/- (Rupees Four Lakh Seventy-Five Thousand Nine Hundred Ninety-Four only) or equivalent in US \$ or € will be paid at the time of admission.
