LIST OF PROVISIONALLY SELECTED CANDIDATES

The following candidates (Lists A to H) are hereby informed that the status of their provisional admission is indicated against their respective names.

Candidates whose Status of Provisional Admission is "CONFIRMED" (Lists A to H) are required to pay the University fee of *Rs. 2,72,253/- (Rupees Two Lakh Seventy-Two Thousand Two Hundred Fifty-Three Only) through the ICICI Bank Payment Gateway. Failure to deposit the fee within the stipulated period shall result in the forfeiture of their admission to the University for the Academic Year 2026-27.

*Candidates whose Status of Provisional Admission is marked as "CONFIRMED" (Lists A to H) and whose daily bank transaction limit is less than the prescribed University fee of ₹2,72,253/- may pay the fee in two or three transactions through the same ICICI Payment Gateway using UPI, Debit/Credit Card, or Net Banking. However, the entire fee must be paid within the stipulated period mentioned for the confirmed candidates, **failing which the admission shall stand cancelled and would be offered to the next wait-listed candidates.**

Any vacant seats remaining in the categories mentioned below shall be filled from the waitlisted candidates, as and when required, strictly on the basis of their All India Rank (AIR) in CLAT-2026 and as per the reservation policy of Bihar Govt. for admission to the Academic Year 2026-27.

Note:

- (1) All admissions would be taken on the basis of the candidates All India Rank (AIR) of CLAT-2026 and admission is also subject to reservation as per the Bihar (In Admission in Educational Institutions) Reservation Act, 2003 (Bihar Act 16 of 2003) and as per the Bihar Reservation in vacancies in posts and in services and in Admission in the Educational Institutions (For Economically Weaker Sections) Act, 2019.
- (2) The University does not guarantee admission to waitlisted candidates. Admission shall

be granted only upon the conversion of a candidate's **Status of Provisional Admission** from **"Waitlisted"** to **"Confirmed."**

In the event that the waitlist of any category is exhausted, further candidates under that category shall be considered from the merit list prepared on the basis of their **All India Rank (AIR)**, as published in the **"Final List of Applications Received Against the Vacant Seats / Against the Subsequent Vacancy Admission Notification dated 01.06.2026 for B.A., LL.B. (Hons.) / B.B.A., LL.B. (Hons.) Course, Academic Year 2026-27,"** published on 12.06.2026 on the University website.

The date of provisional admission and the last date for payment of the University fee shall be displayed against the candidate's name. Thereafter, such candidates shall be required to pay the University fee of **₹2,72,253/- (Rupees Two Lakh Seventy-Two Thousand Two Hundred Fifty-Three Only)** through the ICICI Bank Payment Gateway.

Failure to pay the University fee within the prescribed period shall result in the forfeiture of the candidate's admission to the University for the Academic Year 2026-27.

REFUND POLICY

The last date of admission will be **31st July, 2026**. If any admitted student in B.A., LL.B. (Hons.)/ B.B.A., LL.B. (Hons.) course for the Academic Year 2026-27 intends to withdraw from the said courses the following five tier system for the refund of fees remitted by the students as per UGC Notification on Refund of Fees and Non-Retention of Original Certificates issued in October 2018 shall apply:

Note : Refundable deposits shall be refunded in full.

NOTE :

1. The dress code is compulsory for the first two months of first semester, all the official functions and the Moot Courts (including Intra Moot Court Competitions) of the University. Hence, the students should get the dress ready which includes Black Trousers, White Shirt, Black Coat, Black Tie and Black Shoes, etc. On regular class days the students shall attend the classes with formal wear in conformity with the Bar Council of India Rules.
2. The students should bring the following items for hostel accommodation, if provided:

- The Medical facility on the campus is limited for minor ailments only. If student is suffering from any ailment / disease which warrant medical consultation on regular / frequent basis students and their parents need to make their own arrangements.
 - No vehicle is allowed inside the Gate No. 2 of the University campus. Students are discouraged to have four wheelers. The students shall park their two wheelers (outside the Gate No. 2) in the parking area of the University at their own risk. Failure to observe these Rules entails heavy penalty.
 - The University upholds integrity, character, discipline and academic excellence to which every student must contribute. Students shall observe and adhere to the rules and regulations of the University. **Ragging and sexual harassment in any form is banned and is a punishable offence** and will entail immediate expulsion from the University. Use of any uncivilized or abusive or filthy language against a fellow student, teachers, non-teaching staff, outsourced personnel etc. and causing nuisance (including playing loud music, bursting firecrackers) will invite strict disciplinary action.
 - The University has already constituted an Anti-ragging Squad and Anti-ragging Committee. The faculty would be doing their best to mould the career of every student in a manner that the University can justifiably be proud of. In this effort constant and continuing support of the parents is also solicited. Parents should accompany their wards at the time of joining of the University, so as to interact with the Vice-Chancellor, Registrar, Faculty and the Wardens.
 - The University endeavours to inculcate, cultivate and develop in every student human dignity, fundamental moral values and high standards of discipline. The University is a non- smoking zone and consumption and possession of intoxicating liquors and psychotropic substances is punishable offence and is strictly prohibited (**Reference: The Bihar Prohibition and Excise Act, 2016**).
