

Proceedings of the NIQ No. 18/2026-27 dated 21.05.2026 for Providing Security Services, Tender-Bid Evaluation Committee meeting held on 27.07.2026 in the Chamber of the Registrar to scrutinize and evaluate the Financial Bids submitted by the technically qualified bidders for the tender invited for providing Security Services

All together 12 (Twelve) bidders participated in tender invited for Security Services. After detailed scrutiny of the Technical Bids, 08 (Eight) bidders were found technically responsive and qualified for opening of the Financial Bids, as uploaded in eproc2 website. Accordingly, the Financial Bids of technically responsive bidders were opened on 20.07.2026 in the presence of the Committee members.

Thereafter, the Committee scrutinized the Financial Bids in detail with reference to the tender conditions, statutory wage provisions, and the prescribed Bill of Quantities (BOQ).

The comparative statement of the financial bids submitted by the technically qualified bidders is as follows:

Rs. 763878.84/- (has quoted for 30 days wages in his bid)		As later clarified via email that, the rate is quoted by the firm in their Financial Bid is inclusive of 4 days rest relieving charges that is for 26+ 4 =30 days . Every employee will be given 4 days weekly off during the month and in his /her place a reliever needs to be provided . As such, the impact of cost per head will be 26 days +4 days =30 days a month including relieving duty against particular post /person. However, the EPF and ESI are calculated on 26 days monthly wages. the bidder has put a condition that in case of Minimum Wages for 26 days . a provision for extra reliever has to be provided for working as rest and absentee reserve additionally or to be adjusted out of existing number of employees by making a roster format accordingly . Thus, the conditional bid is not acceptable.

Recommendation of the Tender Bid Evaluation Committee

After detailed scrutiny and deliberation, the Tender Bid Evaluation Committee unanimously observed that the financial bids submitted by the following two bidders are in conformity with the terms and conditions of the tender document:

- 1. **M/s. AGGAR SECURITY SERVICES (INDIA) PRIVATE LIMITED**
- 2. **M/s. OM SHRI SECURITY SERVICES**

The Committee further observed that the above two bidders have quoted the **same financial rate**.

In view of the tie in the quoted price, the Committee referred to **Note No. 2 of Annexure III (Financial Bid Format)** of the Tender Document, read with the **Corrigendum dated 02.06.2026**, which provides that, in the event of a tie in the quoted price, the bidder having the **highest annual turnover** shall be considered eligible for the award of the tender, subject to fulfillment of all other eligibility conditions.

Accordingly, The committee unanimously recommend that after satisfactory verification of all documents , certificate, license, statutory registrations, turnover, credentials and other supporting documents, in case the same being found genuine and inconformity with the tender conditions , the work may be awarded to **M/s. AGGAR SECURITY SERVICES (INDIA) PRIVATE LIMITED** , being the bidder having the highest annual turnover among the tied up bidders, in accordance with Note No. 2 of Annexure III Subject to of the Tender Document read with the Corrigendum dated 02.06.2026.,after, approval from competent authority .
