In pursuance of recommendation of Technical Evaluation dated 02.07.2026, Objections / complaints were invited from Bidders up to 08.07.2026 till 04:00 PM.

Following 05 (Five) Bidders have submitted their clarification regarding responsiveness of their eligibility criteria as mentioned in the minutes of Tender Bid Evaluation Committee dated 02.07.2026:

2. M/s. Eversai Facility Management Services Pvt. Ltd.
3. M/s. Mani Sri Enterprises (P) Ltd
4. M/s. Asylum Security & Intelligence Pvt. Limited.
5. M/s. Simanchal Divine & Security Services

1. M/s. ESEPL Group

In clarification uploaded by M/s. SEPL Group dated 07.07.2026, the bidder has submitted copy of Tender /Quotation Call Notice No. 03/2025 invited by Principal District and Session Judge, Bhagalpur along with details of tender in which total area for work has been mentioned as 3,97,019 Sqft (page 64-69). The Bidder had uploaded copy of agreement with Judgeship of Bhagalpur (page 69-61) in the tender.

The clarification uploaded by M/s. ESEPL Group may be accepted and M/s. ESEPL Group may be declared Responsive.

2. M/s. Eversai Facility Management Services Pvt. Ltd.

The Bidder M/s. Eversai Facility Management Services Pvt. Ltd. has uploaded experience details till 17.02.2026 in which total area cover of (i) M/s. Global Health Care Private Limited (Medanta) is mentioned as 10,00,000 Sqft. and (ii) M/s. Himalaya Medical College and Hospital is mentioned as 10,89,000 Sqft. The Bidder has previously uploaded copy of agreement with the two organisations in tender which did not mention Total Area Covered.

The Committee unanimously recommended that the clarification regarding area covered under agreement (work area) may be accepted subject to confirmation of the area by concerned authorities of (i) M/s. Global Health Care Private Limited (Medanta) and (ii) M/s. Himalaya Medical College and Hospital along with other Documents in case the Bidder M/s. Eversai Facility Management Services Pvt. Ltd becomes L1 after opening of Financial Bid.

3. M/s. Mani Sri Enterprises (P) Ltd.

Request by M/s. Mani Sri Enterprises Private Limited has not been found by Committee unanimously to be acceptable because M/s. Mani Sri Enterprises Pvt. Ltd. has requested to consider his work experience of CNLU during FY 2014-15, which is out of consideration zone of previous three financial year i.e., 2022-23, 2023-2024, 2024-25 as advertised in tender.

4. M/s. Asylum Security & Intelligence Pvt. Limited, Fraser Road, Patna has uploaded copy of Work Order, CONTRACT AGREEMENT dated 29.01.2026 effective from 01.10.2025 and copy of TAX INVOICE dated 05.06.2026 raised to Bihar Institute of Correctional Administration, Hajipur in which Area is mentioned as 3,24,442 Sqft.

The clarification uploaded by M/s. Asylum Security & Intelligence Pvt. Limited, Fraser Road, Patna may be accepted subject to verification of TAX Invoice dated 05.06.2026 from “Bihar Institute of Correctional Administration (BICA), Hajipur along with other documents, in case M/s. Asylum Security & Intelligence Pvt. Limited, Fraser Road, Patna becomes L-1 after opening of Financial Bid.

5. M/s. Simanchal Divine & Security Services

Bidder M/s. Simanchal has not uploaded information regarding area anywhere. Hence, clarification papers uploaded by M/s. **Simanchal Divine & Security Services is not acceptable.**

Recommendations of Technical Bid Evaluation Committee

Complaint objection raised by the above 05 Bidders and documents related to clarification uploaded by them was examined in meeting of Technical Bid Evaluation Committee on 14.07.2026. After thorough examination of uploaded papers relating to clarification by the committee. It was recommended unanimously to declare following 03 (Three) Bidders also Responsive:

1. M/s. ESEPL Group
2. M/s. Eversai Facility Management Services Pvt. Ltd.
3. M/s. Asylum Security & Intelligence Pvt. Limited, Fraser Road, Patna

Thus, the following 12 Bidders are recommended to be declared Responsive including 09 bidders already declare responsive in meeting dated 02.07.2026 subject to verification and confirmation of Documents from respective authorities:

On verification of documents uploaded by M/s. Creative Industrial Security Force Private Limited, it has been reported by issuing Authority that the certificate / document is forged. In this situation the committee unanimously recommended the above firm should be debarred / blacklisted for participation in future tenders/quotations.
