Recommendations of Technical Bid Evaluation Committee

In pursuance of recommendation of Technical Evaluation Committee dated 02.07.2026, complaint Objections (if any) was invited from Bidders up to 08.07.2026 till 04:00 PM.

The following 03 (Three) Bidders raised objection / complaint within stipulated time.

1. **M/s. S24 CONSULTANCY & SERVICES**
2. **M/s. JASBIR SINGH KABERWAL SECURITY AGENCY**
3. **M/s. AADHAMAR SOLUTIONS PRIVATE LIMITED.**

The Technical Evaluation Committee examined objection raised and supporting papers uploaded and supporting papers uploaded by these Bidders. After thorough discussion, it was recommended to declare the following Bidders also Responsive in addition to 06 (Six) Bidders recommended to be declared Responsive in meeting dated 02.07.2026:

1. M/s. S24 CONSULTANCY & SERVICES:

The clarification uploaded by M/s. S24 Consultancy & Services is acceptable and hence, the committee recommended to declare the Bidder Responsive.

2. M/s. JASBIR SINGH KABERWAL SECURITY AGENCY

Objection raised by the Agency **has not been found valid** by the Committee due to reason that in the Tender, has uploaded EPFO return statement (Regular Return) : April 2026 which is showing list of only 106 Personal. The NIQ No. 18/2026-27 dated 21.05.2026 eligibility criteria (B-VI) clearly mentions that documentary proof showing availability of at least 200 Trained Security Personnel with valid UAN numbers under EPFO records. The Bidders has not been found this conditions even in his clarification uploaded. Hence, the committee did not find the Bidder eligible to be declared Responsive.

3. M/s. AADHAMAR SOLUTIONS PRIVATE LIMITED:

Objections raised by the Agency has also not been found to be valid because the certificate of Registration regarding compliance of ISO 18788:2015 is not valid. The Bidder has uploaded / submitted copy of another certificate of compliance regarding confirming the requirements of ISO 18788:2015. Since, the Bidder has uploaded altogether a new certificate, the objections by Bidder **has not been found to be acceptable.**

Recommendations of Technical Bid Evaluation Committee

Complaint objection raised by the above 03 Bidders and documents related to clarification uploaded by them was examined in meeting of Technical Bid Evaluation Committee on 14.07.2026. After thorough examination of uploaded papers relating to clarification by the committee. It was recommended unanimously to declare following 01 (One) Bidder also Responsive:

1. **M/s. S24 CONSULTANCY & SERVICES**

Thus, the following 07 (Seven) Bidders are recommended to be declared Responsive including 06 bidders already declare responsive in meeting dated 02.07.2026 subject to verification and confirmation of Documents from respective authorities:

- 2. M/s. SIMANCHAL DIVINE AND SECURITY SERVICES PRIVATE LIMITED**
- 3. M/s. OM SHRI SECURITY SERVICES**
- 4. M/s. ASYLUM SECURITY & INTELLIGENCE PRIVATE LIMITED**
- 5. M/s. SURGICAL SECURITY AND CONSULTANCY PRIVATE LIMITED**
- 6. M/s. ADWIK SECURITY & HR SOLUTIONS PVT LTD.**
- 7. M/s. S24 CONSULTANCY & SERVICE.**

The bidders may raise objections (if any) on or before **16.07.2026 till 04:00 pm**. No further time for revisional clarification shall be allowed and no further clarification shall be entertained.

On verification of documents uploaded by M/s. Creative Industrial Security Force Private Limited and M/s. Kartik India Manpower Private Limited, it has been reported by issuing Authority that the certificates / documents are forged. In this situation the committee unanimously recommended the above both firms should be debarred / blacklisted for participation in future tenders/quotations.
