- v) The price will be remained firm and fixed during the pendency of contract. It will not vary on any account including revision of taxes, imposition of new tax or any contingency whatsoever.
- vi) Incomplete bid and bid without genuine documents are liable for rejection. No responsibility will be taken for any type of technical glitch while offline submission of bid.

If the work is not completed within the stipulated completion period liquidated damages @ 0.5% of agreement value per day of delay will be levied (subject to maximum of 10%). If the liquidated damages reach the level of 10% the agreement value the contract is liable to be rescinded.
- ix) Work shall be done strictly as per specification and direction of competent authority of CNLU, Patna.
