AMENDMENT IN ACADEMIC REGULATIONS EFFECTIVE FROM ACADEMIC SESSION 2026-2027

(As Amended in May 2026)

Partial amendments in the Academic Regulations applicable to all PG and UG programmes of the University i.e. B.A.,LL.B. (H) & B.B.A.,LL.B. (H), 3 Year LL.B. (H), and LL.M. are to be implemented with effect from June/July 2026.

ATTENDANCE

Marks shall not be awarded for attendance in any of the courses. However, a **minimum of 75% attendance** shall be mandatory for a student to be eligible to appear in the semester examinations in a given course.

Compensatory attendance shall not be granted under any circumstances on account of participation in extracurricular activities, events, presentations, seminars or any other engagements.

The 5 (five) marks earlier assigned for regularity of attendance will now be merged/ added to other components of all the courses.

- **UG:** The Mid-Semester Examination shall be conducted for **20 (twenty)** marks.
- **PG:** The Project work in each paper will be of **30 (thirty)** marks out of which 20 (twenty) marks for written project and 10 (ten) marks will be allotted to the presentation/ viva voce.

There will be NO Written Examination for this Clinical Course "Drafting, Pleadings and Conveyancing" (DPC). The course shall instead be evaluated based on the following scheme of evaluation as continuous assessment which will be conducted in the class regularly every week throughout the semester:

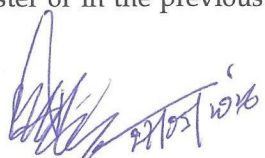
Drafting of Civil Pleadings	30 Marks

Following scheme would be applicable for Research Publications and Moot Court Memorials etc.:

Vis, ICC Moot Court Competition, Stetson International Environmental Law, Monroe E. Price Media Law, Nelson Mandela World Human Rights	Exemption from all the six/ five (6/5) Projects as the case may be in a particular semester
(ii)	Research Paper in SCOPUS Q2 indexed Journal or Web of Science Journal or Best Moot Court Memorials at the National Round in prestigious International Moot Court Competitions such as Philip C. Jessup, Willem C. Vis, ICC Moot Court Competition, Stetson International Environmental Law, Monroe E. Price Media Law, Nelson Mandela World Human Rights	Exemption from four (4) Projects
(iii)	Research Paper in SCOPUS Q3 indexed Journal or Best Memorial in the National Moot Court Competitions such as those organized by Bar Council of India or any NLU or Surana and Surana, Competition Commission of India, NHRC and K. K. Luthra	Exemption from three (3) Projects
(iv)	Research Paper in SCOPUS Q4 indexed Journal/ NLU's Journals/ Journal of Indian Law Institute or Best Memorial Award in any National Moot Court Competition, Best Researcher Award in National Judgment writing Competition and National PIL Drafting	Exemption from two (2) Projects

Note: The students will have to give Viva on their published Research Paper or the Memorials as the case may be. The Research Paper can be published either in the existing semester or in the previous semester.
